DBAY Advisors Limited (“DBAY”) - extension of PUSU deadline

On 9 September 2019, the Board of Eddie Stobart Logistics plc (“Eddie Stobart” or the “Company”) confirmed that it had received a preliminary expression of interest from DBAY in relation to a possible offer to be made by funds managed by DBAY for the entire issued, and to be issued, share capital of the Company (the “Possible Offer”). The announcement stated DBAY was required, by not later than 5.00 p.m. on 7 October 2019 (the “PUSU Deadline”), either to announce a firm intention to make an offer for the Company in accordance with Rule 2.7 of the Code or to announce that it did not intend to make an offer for the Company, in which case the announcement would be treated as a statement to which Rule 2.8 of the Code applies.

Discussions with DBAY are ongoing in relation to the Possible Offer and the Company has requested that the Panel on Takeovers and Mergers (the “Panel”) extend the PUSU Deadline. In light of this request, an extension has been granted by the Panel and, in accordance with Rule 2.6(a) of the Code, DBAY is required, by not later than 5.00 p.m. on 16 October 2019, either to announce a firm intention to make an offer for the Company in accordance with Rule 2.7 of the Code or to announce that it does not intend to make an offer for the Company, in which case the announcement will be treated as a statement to which Rule 2.8 of the Code applies. This deadline can be extended further with the consent of the Panel, at the Company’s request, in accordance with Rule 2.6(c) of the Code.

TVFC (3) Limited (“TVFC”)

As announced by the Company on 18 September 2019, in accordance with Rule 2.6(a) of the Code, TVFC (3) Limited (“TVFC”), a company controlled by Andrew Tinkler, is required, by not later than 5.00 p.m. on 16 October 2019, either to announce a firm intention to make an offer for the Company in accordance with Rule 2.7 of the Code or to announce that it does not intend to make an offer for the Company, in which case the announcement will be treated as a statement to which Rule 2.8 of the Code applies. This deadline can be extended with the consent of the Panel in accordance with Rule 2.6(c) of the Code.

There can be no certainty either that an offer will be made nor as to the terms of any offer, if made. A further announcement will be made when appropriate.

An Opening Position Disclosure by a person to whom Rule 8.3(a) applies must be made by no later than 3.30 pm (London time) on the 10th business day following the commencement of the offer period and, if appropriate, by no later than 3.30 pm (London time) on the 10th business day following the announcement in which any securities exchange offeror is first identified. Relevant persons who deal in the relevant securities of the offeree company or of a securities exchange offeror prior to the deadline for making an Opening Position Disclosure must instead make a Dealing Disclosure.

Under Rule 8.3(b) of the Code, any person who is, or becomes, interested in 1% or more of any class of relevant securities of the offeree company or of any securities exchange offeror must make a Dealing Disclosure if the person deals in any relevant securities of the offeree company or of any securities exchange offeror. A Dealing Disclosure must contain details of the dealing concerned and of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror, save to the extent that these details have previously been disclosed under Rule 8. A Dealing Disclosure by a person to whom Rule 8.3(b) applies must be made by no later than 3.30 pm (London time) on the business day following the date of the relevant dealing.

If two or more persons act together pursuant to an agreement or understanding, whether formal or informal, to acquire or control an interest in relevant securities of an offeree company or a securities exchange offeror, they will be deemed to be a single person for the purpose of Rule 8.3.

Opening Position Disclosures must also be made by the offeree company and by any offeror and Dealing Disclosures must also be made by the offeree company, by any offeror and by any persons acting in concert with any of them (see Rules 8.1, 8.2 and 8.4).
